Gordon Leong



Gordon Leong, Fenton, MO, has a B.S. in Chemical Engineering and an MBA, focus on Finance, from Washington University, St. Louis, MO. Gordon has worked for ICL for the last 17 years. He is currently the Engineering and Technology Manager, managing a technical staff that provides technical support to the manufacturing sites. His focus includes process development and startup of a manufacturing plant, implementing operational excellence practices, and specialized engineering support for the sites. In addition, he is responsible for evaluating global capital projects. His previous role with ICL was the Plant Manager of the Lawrence, Kansas facility where he was responsible for the operations of the site which includes 130 employees and an annual budget of \$94M. Gordon's responsibilities included driving safety, environmental, cost, reliability, guality, and maintenance improvements. One area of focus was developing knowledge regarding capital budgeting and evaluations. Prior to that, he was the Manufacturing Manager at the Carondelet Plant, St. Louis, Missouri, where he was responsible for the manufacturing operations for two of the four operating facilities. His main focus was the cost effective and reliable operations of these units.

Gordon is currently on the Analytics Committee and the Scholarship and Endowment Committees. In prior years, Gordon has helped with the Scholarship review process. In addition to Gordon's interest in the ESA Foundation, he has been involved with the Boy Scouts of America since 2003, where he's held positions of Cubmaster, St. Louis Area Council, responsible for the monthly pack meetings and operations of the pack; Committee Chair, St. Louis Area Council – Local Troop, responsible for the operations of the troop, oversaw the BSA program for the troop to insure rank advancement, and leadership opportunities for the scouts; and Unit Commissioner – Heart of America Council, where he provided support and guidance for two cub scout packs and a Scouting BSA troop. Gordon has been an ESA Foundation member since 2020.

Gordon says "I have been working with kids for a number of years through Scouting, teaching Scouts life, leadership, and practical skills. It is a very rewarding experience to watch kids grow as they progress through the program. Contact your IRA administrator for more details and, when ready, reach out to ESA Headquarters for directions of how and where to send your check and/or electronic transfer. Plan ahead so your contribution gets credited prior to December 31st.

ESA Foundation's "Turn-around" Fund

Each year the ESA Foundation has questions about how the ESAF "Turn-around Fund" works. Here are a few guidelines and helpful hints about how the Turn-around funds can be applied for and help to get you through the process.

As you know, our members support many different organizations in addition to the ESA Foundation. Many years ago, the ESA Foundation Board of Directors came up with a way members could support both the ESA Foundation and other charitable organizations at the same time! The solution was the "Turnaround Fund" (TAF) which, in its simplest form, means that someone or some entity wants to donate to XYZ Charity. That person or entity writes a check to the ESA Foundation (our own charitable organization), and we deposit the check. We then "turnaround" and write a check to the other designated charity of choice in the exact same amount, checks can be sent directly to the charitable organization or to the chapter for presentation. ESA Foundation and its members are credited with the donation and the funds end up in the organization for which they were intended in the first place! A Win-Win for everyone! Of course, as with any program, there are rules!

Many years ago, our good friends at the Internal Revenue Service asked us to tighten up a bit when it came to whom we were writing TAF checks (i.e., we can only write them to other "charitable" organizations). The IRS defines charitable as those entities that it has granted a 501(c) 3 status, plus educational organizations such as government-run schools. (A special reminder on schools, TAF checks cannot be written to any school for the benefit of a specific person.) Those requesting TAF checks must provide ESA Headquarters staff with verification of the payee(s) 501(c) 3 charitable organization status. Remember, all we need to do is verify the charitable status of your payee and there are at least two avenues that are totally acceptable. One is to look up your request on the Internet at www.guidestar.com. If your TAF payee is "charitable" it will undoubtedly be listed on this website. You'll need to know the organization's exact name. For example, "March of Dimes" is actually "March of Dimes Foundation," and "Goodwill" is really "Goodwill Industries International, Inc." If you find your payee on the Guidestar website, please put the exact name of the charity and its EIN on your contribution form. This will make the process of verification very simple for us. If your payee is not listed on Guidestar, chances are it isn't charitable and you will need to contact them to obtain a copy of their 501(c) 3 status, as issued by the IRS. Another sure method is to ask the potential payee for a copy of their IRS-generated "determination letter" verifying their 501(c) 3 status.

Turn Around Fund process

Always review and take a few extra minutes when filling out your contribution form to verify the charitable status of your TAF payee's request. It will save everyone a lot of time. We simply can't write a check to an entity that we can't verify is charitable. Of course, once you've sent Headquarters the verification of charitable status you'll never need to do it again. We'll record it in our database for future use. Here are some simple rules:

- Checks sent to the Turn Around Funds (TAF) must be made payable to the "ESA Foundation."
- TAFs must be a minimum of \$25.
- TAF checks may only be issued to other IRS designated 501(c) 3 charitable organizations. The recipient entity's 501(c) 3 IRS-generated determination letter must accompany the initial request. This letter will include the entity's EIN (employer identification number), which is also a requirement.
- TAF checks not cashed within 120 days of the date of issue will be considered a donation to the ESA Foundation General Fund.

The IRS does not allow any of the following when it comes to TAFs:

- TAF checks issued directly to an individual.
- TAF checks written to a school for the direct benefit of any individual. TAF checks written to any other "ESA Entity" (ESA Foundation is the only 501(c) 3 charitable organization within the ESA Family).
- TAF checks written to the EPSILON SIGMA ALPHA INTERNATIONAL COUNCIL Disaster Fund.
- TAF checks written to State/ Region Love or Care Funds.

If you have additional questions, Headquarters is always glad to assist. Doug and Mandy are a great source to help.
